Explanation of responses:

- (1) Represents shares of common stock that may be issued upon the vesting of a like number of restricted stock units granted on September 15, 2008. As restricted stock units vest, the vested units are automatically converted to vested common stock on a one-for-one basis without payment of additional consideration on the vesting date. The units vest in four equal installments on September 15, 2009, September 15, 2010, September 15, 2011 and September 15, 2012.
- (2) Of these securities, 25% vest on September 15, 2009, and 2.0833% vest monthly thereafter so that the options are fully vested on September 15, 2012.
