Explanation of responses:

- (1) The 12,776 restricted stock units granted on December 12, 2006 vested 50% on December 21, 2007 and the remainder vested on December 23, 2008 based on Novell's satisfaction of certain performance criteria. As restricted stock units vest, the vested units are automatically converted to vested common stock on a one-for-one basis on the vesting date.
- (2) The 48,762 restricted stock units granted on February 2, 2007 vested 40% on December 21, 2007 and the remainder vested on December 23, 2008 based on Novell's satisfaction of certain performance criteria. As restricted stock units vest, the vested units are automatically converted to vested common stock on a one-for-one basis on the vesting date.
- (3) Each restricted stock unit represented the contingent right to receive one share of Novell common stock.
- (4) On December 18, 2007, the reporting person was granted an option to purchase 58,215 shares of common stock. The option vests in four equal annual installments based on Novell's satisfaction of certain performance criteria for each of the fiscal years ending October 31, 2008, 2009, 2010 and 2011. The performance criteria for 2008 were met, resulting in the vesting of the option as to 14,553 shares.
