## 1 What's New

- ◆ **Product Data Collection:** Anonymous product usage and information collection has been added to Messenger 3.0.2. Enabled by default, this sends the collected information to Novell to help us improve the product. You can disable this option during the install/upgrade or by using a startup switch. For more information, see [/productinfo](#) in the *Novell Messenger 3.0 Administration Guide*.
- ◆ **New SSL Startup Switches:** Additional startup switches have been added for SSL to both the Messaging agent and the Archive agent:
  - ◆ [/dhparm](#): Allows you to specify a Diffie-Hellman parameters file for SSL/TLS.
  - ◆ [/ssloption](#): Allows you to disable specific SSL protocols.
- ◆ **New Platform Support:** The following platforms are now supported:
