The document specifically refers to Sentinel Log Manager 1.2.0.2. However, the same procedure is applicable for Sentinel Log Manager 1.2.0.3.

**NOTE:** This hotfix does not have an update for remote Collector Managers. The Collector Manager 1.2.0.2 version, which is the latest, is compatible with Sentinel Log Manager 1.2.0.3. On systems with the remote Collector Manager 1.2 or 1.2.0.1 version, you need to upgrade the Collector Manager to the 1.2.0.2 version.

## 4 Defect Fixed

**Issue:** Report Administrators have permission to create data retention policies by using the *save query as > save as retention policy* option in the Search results page. (BUG 771634)

**Fix:** Report Administrators no longer get the option to create data retention policies. Only users in the administrator role have access to create data retention policies.
