What's New in Nokia Intellisync Wireless Email 9.2

Nokia Intellisync Wireless Email version 9.2 is a maintenance release that addresses customer feedback and introduces new features since the previous version (9.1) was released.

Issues Resolved in Wireless Email 9.2

The following issues were resolved in the Wireless Email 9.2 release.

- On the Web site, an application error appears when you save changes to the Performance Settings page. This issue is resolved; reference 86775.
- In WebAdmin Console Wireless Email User Settings, the word "attachment" is misspelled. This issue is resolved; reference 86981.
- In WebAdmin Console Wireless Email User Settings for Novell GroupWise, distribution lists do not display correctly. This issue is resolved; reference 87057.
- After upgrading the server to Wireless Email version 9.2, the database service (asadb) will not restart. This issue is resolved; reference 87427.
- In the Finnish language version of the client, translation of the phrase "software installation" should be changed to a better grammatical form. This issue is resolved; reference 87569.
- When stopping services on Red Hat Linux Enterprise 4.5 and SUSE Linux Enterprise 10, the command does not always stop the daemon processes. This issue is resolved; reference 87662.
- The on-device help for the S60 client references features that are not available in the client. This issue is resolved; reference 87972.
- When upgrading the server to Wireless Email version 9.2, the database schema is not upgrading correctly This issue is resolved; reference 88219.
- User authentication issues exist after adding a new Novell GroupWise authentication source. This issue is resolved; reference 89558.
- On some J2ME devices, meeting invitations are synchronized back to the device after being accepted, declined, or marked tentative on the device. This issue is resolved; reference 86904.

Known Issues in Wireless Email 9.2

The following items are known issues in the Wireless Email 9.2 release.

- In certain cases, an appointment may not update correctly in Novell GroupWise after changing it from a recurring appointment to a single appointment. Reference 87617.
- When using the Mark Unread menu option on a Symbian OS client, the unread mark does not transfer from the client to the GroupWise server. Reference 87673.
- The setting in a user's profile to allow synchronization of attachments less than a specific file size does not transfer to Windows Mobile devices. The Max Attachment Size option is not selected on the device, and attachments larger than the designated maximum size continue to synchronize to and from the device. Reference 87824.

- If you activate User Access Control in Corporate Email Connector for Workgroups on Windows Vista, data does not transfer between the server and the Exchange server. Reference 80867.
- On the Web site, when you accept a meeting invitation sent from a Gmail account, but you do not send a response to the person who sent the request, the meeting does not appear in your calendar and the invitation remains in your Inbox. Reference 81076.
- When adding a POP/IMAP connection that was recently removed, the following error message appears: An error occurred when trying to login to the server. Reference 78242.
- On the Web site, viewing any attachment that contains the "&" character in the file name results in an application error. Reference 85376.
