2.1 Launching XREG.EXE Fails

This problem occurs if you attempt to run ZENworks Application Virtualization on a machine that does not have the Microsoft* .NET Framework installed.

Workaround: Download the .Net 2.0 xlayer (http://www.xenocode.com/Products/common/Xlayers/ MSNet_x86_2.0.50727_2.xlayer) and copy it to the same directory as XREG.EXE.

2.2 Using Search from the Help inside ZENworks Application Virtualization causes the application to crash

The ZENworks Application Virtualization packager might crash if you perform a search using help from inside the application.

Workaround: To search the help, use the Help link from the Start Menu (*Start > Programs > ZENworks Application Virtualization 7.1 > ZENworks Application Virtualization 7.1 Help*) instead of using the *Help* link in the ZENworks Application Virtualization application.
